WHEREAS, under Section 35 of the Republic Act No. 7160 otherwise known as the "Local Government Code" of 1991 and Article X, Section 13 of the 1987 Philippine Constitution, allows local government units (LGUs) to consolidate efforts for common benefit;

WHEREAS, pursuant to the above-stated portions of the local government code and the 1987 Philippine Constitution, the City Government of Manila is strengthening its ties with the different municipalities and provinces in the Philippines, through establishing friendship and concern for each other;

WHEREAS, the Sangguniang Panlalawigan of the Province of Romblon, approved Resolution No. 08-2025-38 on August 5, 2025, entitled: "A RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A SISTERHOOD RELATIONSHIP BETWEEN THE PROVINCE OF ROMBLON AND THE CITY OF MANILA";

WHEREAS, the Province of Romblon through Honorable Governor Trina Alejandra Q. Firmalo-Fabic has expressed its interest in establishing a twinning agreement with the City of Manila to enhance political, economic, social, cultural, and educational areas of development and progress between the two LGUs last August 5, 2025;

WHEREAS, this proposal is in response to the request of the Sangguniang Panlalawigan of the Province of Romblon, for a Twinning Agreement with the City of Manila, and in forging an exchange program of its residents and resources which are mutually beneficial to both parties;

WHEREAS, the City Council deemed such proposal as essentially contributory in the furtherance of and shall intensify the friendly ties with the Sangguniang Panlalawigan of the Province of Romblon, consistent with its policy of peace, equality, justice, freedom, cooperation and amity with municipalities in the Philippines, and, therefore, it sees merit on the said request and thus manifests its concurrence: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the City Mayor Honorable Francisco "Isko Moreno" Domagoso, to enter into and execute the Twinning Agreement of the City of Manila with the Province of Romblon; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished to the Sangguniang Panlalawigan of the Province of Romblon.


