WHEREAS, in a letter dated September 28, 2025, the Honorable City Mayor of Malabon, Jeannie N. Sandoval, has requested the Honorable City Mayor Francisco "Isko Moreno" Domagoso, for adoption of a resolution to enter into a Memorandum of Agreement (MOA) covering the secondment of Atty. Regina M. Casidsid-Portento, as Assistant Department Head, City Human Resource and Management Office, City of Malabon;

WHEREAS, a secondment is a way to enable the parties to benefit by temporarily assigning experts occupying managerial, professional, technical, and scientific positions from their respective administrations and exchange high level of expertise and professional knowledge. For this reason, steps should be taken to facilitate the use of managerial, professional, technical and scientific knowledge and skills of personnel drawn from the administrations of parties: NOW THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor Francisco "Isko Moreno" Domagoso, representing the City Government of Manila, authority to enter into a Memorandum of Agreement with the City Government of Malabon, represented by its Honorable City Mayor Jeannie N. Sandoval, covering the secondment of Atty. Regina M. Casidsid-Portento, as Assistant Department Head, City Human Resource and Management Office, Malabon City; and be it FURTHER

RESOLVED, that the MOA to be entered into by the parties authorized by this Resolution shall be submitted to the City Council for ratification.
