AN ORDINANCE ADOPTING THE DBM BUDGET CIRCULAR NO. 2024-5 DATED DECEMBER 10, 2024 AND DBM BUDGET CIRCULAR NO. 2021-2 DATED AUGUST 25, 2021, WHICH SHALL BE EFFECTIVE FROM JANUARY 1 TO DECEMBER 31, 2025

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION. 1. DBM Budget Circular No. 2024-5 is being adopted by the City Government of Manila, which provides that Psychologist I, II and III positions shall be upgraded not later than January 1, 2025, to wit:

Position Title	Salary Grade	
	From	To
Psychologist I	11	
Psychologist II	15	16
Sychologist III	15	18
Sychologist III	18	20

The concerned departments for the upgrading of the Psychologist positions includes the Department of Social Welfare, Sta. Ana Hospital, Ospital ng Maynila Medical Center (Ospital ng Maynila Lacson-Villegas Medical Center) and the Manila Health Department (MHD).

- SEC. 2. DBM Budget Circular No. 2021-2 is likewise adopted by the City Government of Manila which provides for the modification of the Nurse II position from Salary Grade 15 to Salary Grade 16.
- SEC. 3. The budgetary requirement and modification of the positions amounting to One Million Five Hundred Ninety-One Thousand Nine Hundred Twenty-Six Pesos (PhP1,591,926.00) shall be charged against the Special Activities Fund Personal Services under the FY 2025 Executive Budget, and thereafter shall be included in the succeeding preparation of the Annual Executive Budget of the City of Manila.
- SEC. 4. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.

This Ordinance was enacted by the City Council of Manila on October 9, 2025.
