WHEREAS, with a total land area of thirteen thousand three hundred ten hectares (13,310 ha) and composed of twenty-six (26) Barangays, the Municipality of Pontevedra is one of the sixteen (16) Municipalities of the Province of Capiz, a first-class Municipality located at the center of the First Congressional District of the province;

WHEREAS, located at the center of the Municipalities of Panay, Panitan, Maayon and President Roxas, Pontevedra is considered as one of the largest producers of the best seafoods in the entire country with abundant natural resources;


WHEREAS, with an agri-aqua based economy, Pontevedra's major agricultural resources are rice and sugarcane, carabao, hogs and poultry for livestock, and prawn, crabs and milkfish as some of its major fishery products complimented with industrial and commercial establishments and other economic activities;

WHEREAS, through its Resolution No. 023, adopted last August 13, 2025, the Municipality of Pontevedra, Province of Capiz, through its Secretary to the Sanggunian, Atty. Julius B. Estolano and noted by Honorable Mayor, Henry D. Tumlos, sent a letter-request to Hon. Mayor Francisco "Isko Moreno" Domagoso its intent to establish a Twinning Relationship Agreement with the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the honorable City Mayor Francisco "Isko Moreno" Domagoso, to enter into and execute the Twinning Agreement between the Municipality of Pontevedra, Province of Capiz and the City of Manila; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished to the Municipality of Pontevedra, Province of Capiz.
