RESOLUTION GRANTING THE HONORABLE CITY MAYOR FRANCISCO "ISKO MORENO" DOMAGOSO, REPRESENTING THE CITY GOVERNMENT OF MANILA – YOUTH DEVELOPMENT AND WELFARE BUREAU, AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE SCHOOLS DIVISION OFFICE-MANILA, FOR THE CONDUCT OF THE BOYS AND GIRLS WEEK PURSUANT TO SECTION 30 (B) REPUBLIC ACT NO. 10742 OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015"

WHEREAS, the City Council was in receipt of an indorsement dated 09 October 2025 from the Youth Development and Welfare Bureau (YDWB), the Officer-in-Charge of the Youth Development and Welfare Bureau, Mr. John Daniel M. Layno, requested for the adoption of a resolution granting the Local Chief Executive authority to enter into a Memorandum of Agreement (MOA) for the conduct of the Boys and Girls Week pursuant to Section 30 (b) Republic Act No. 10742 otherwise known as the "Sangguniang Kabataan Reform Act of 2015";


WHEREAS, the indorsement, together with the proposed MOA, was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", empowers the local chief executive to enter into contract on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor Francisco "Isko Moreno" Domagoso, representing the City Government of Manila – Youth Development and Welfare Bureau, authority to enter into a Memorandum of Agreement with the Schools Division Office-Manila, for the conduct of the Boys and Girls Week pursuant to Section 30 (b) Republic Act No. 10742 otherwise known as the "Sangguniang Kabataan Reform Act of 2015"; and be it FURTHER

RESOLVED, that the duly executed Memorandum of Agreement (MOA) entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
