RESOLUTION APPROVING AND ADOPTING VARIOUS RESOLUTIONS PASSED BY THE CITY HEALTH BOARD AIMED AT IMPROVING THE DELIVERY OF HEALTH CARE SERVICES IN THE CITY OF MANILA, AND FOR OTHER PURPOSES

WHEREAS, on October 27, 2025, the Acting City Treasurer Atty. Paul S. Vega, REE, transmitted to this Sanggunian various measures passed by the City Health Board;

WHEREAS, the City Health Board, the policy-making body of the Manila Health Department (MHD) regularly conducts meetings to formulate policies in providing health care programs in the City. Among the resolutions for the consideration of this Body are the following:

1. **RESOLUTION NO. 09 – A RESOLUTION APPROPRIATING TEN MILLION PESOS (Php10,000,000.00) FOR THE PROCUREMENT OF TWO (2) PORTABLE X-RAY MACHINES FOR THE USE OF PRESIDENT CORAZON C. AQUINO GENERAL HOSPITAL, CHARGEABLE UNDER THE SPECIAL HEALTH FUND OF PHILHEALTH;**
2. **RESOLUTION NO. 10 – A RESOLUTION APPROVING THE ALLOCATION OF TEN MILLION PESOS (Php10,000,000.00) FOR THE PURCHASE OF ONE HUNDRED (100) LAPTOPS FOR THE USE OF HEALTH CENTERS UNDER THE MANILA HEALTH DEPARTMENT, AT TWO (2) LAPTOPS PER HEALTH CENTER WITH THE REMAINING UNITS TO BE STORED AT THE MANILA HEALTH DEPARTMENT (MHD);**
3. **RESOLUTION NO. 11 – A RESOLUTION APPROVING THE PARTNERSHIP BETWEEN THE CITY OF MANILA AND DE LA SALLE UNIVERSITY (DLSU) FOR THE IMPLEMENTATION OF PROGRAMS ON TUBERCULOSIS (TB) ANALYTICS, COMMUNITY BASED MENTAL HEALTH, AND L-HEARTS, WITH THE MANILA HEALTH DEPARTMENT (MHD) AS THE LEAD IMPLEMENTING AGENCY;**
4. **RESOLUTION NO. 12 – A RESOLUTION DIRECTING THE ADMINISTRATORS AND PERSONNEL OF THE MANILA NORTH CEMETERY AND MANILA SOUTH CEMETERY TO ESTABLISH/OPERATE ONE (1) CREMATORIUM OPERATIONS IN EACH OF THE SAID CEMETERIES AND TO STRICTLY ADHERE TO THE PUBLIC HEALTH AND SANITATION STANDARDS PRESCRIBED UNDER CHAPTER XXI OF PRESIDENTIAL DECREE NO. 856 (THE CODE ON SANITATION OF THE PHILIPPINES) AND ITS REVISED IMPLEMENTING RULES AND REGULATIONS (IRR), AND PROVIDE TECHNICAL ASSISTANCE, CAPACITY BUILDING AND MONITORING APPROPRIATE REGULATORY AGENCIES;**
5. **RESOLUTION NO. 13 – RESOLUTION APPROVING THE PROPOSED PERSONNEL SCHEDULE AND AUTHORIZING THE CREATION OF ONE HUNDRED FORTY-FOUR (144) PLANTILLA POSITIONS FOR PRES. CORAZON AQUINO GENERAL HOSPITAL**
6. **RESOLUTION NO. 14 – RESOLUTION APPROVING THE AMOUNT OF EIGHTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP18,500,000.00) FOR THE PROCUREMENT OF MILK SUPPLEMENTS FOR DAY CARE CHILDREN AGED THREE (3) TO FIVE (5) YEARS OLD AND ABOVE;**
7. **RESOLUTION NO. 15 – RESOLUTION APPROVING THE ALLOCATION OF TWENTY-FIVE MILLION PESOS (PHP25,000,000.00) FOR THE PROCUREMENT OF ONE HUNDRED (100) UNITS OF ELECTROCARDIOGRAM (ECG) EQUIPMENT FOR THE MANILA HEALTH DEPARTMENT (MHD);**

8. RESOLUTION NO. 16 – RESOLUTION APPROVING THE ALLOCATION OF TEN MILLION PESOS (PHP10,000,000.00) FOR THE ESTABLISHMENT OF AN IN-HOUSE LABORATORY AT PRESIDENT CORAZON C. AQUINO GENERAL HOSPITAL CHARGEABLE TO THE SPECIAL HEALTH FUND;

WHEREAS, the MHD and the City's Seven Hospitals, including the newly opened President Corazon C. Aquino General Hospital will receive the biggest share in the FY 2026 Executive Budget amounting to Two Billion Three Hundred Ninety Million Pesos (PhP2,390,000,000.00) to sustain operations and improve medical services;

WHEREAS, Honorable City Mayor Francisco "Isko Moreno" Domagoso in his message during the signing of the Annual Executive Budget stated that: "*Mahirap magkasakit, napakamahal magkasakit, kaya kailangan tuluy-tuloy ang suporta sa ating matatanda at mga pasyente sa Ospital*": NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to approve and adopt, as it hereby approves and adopts various Resolutions passed by the City Health Board aimed at improving the delivery of health care services in the City of Manila, and for other purposes.
