WHEREAS, the INTRA-TODA STREET MANILA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (INTRA-TODA) INC., with office address at 03 Baluarte Street, Sta. Barbara, Magallanes Brgy. 656, Intramuros, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered People's Organization (PO);
