WHEREAS, the PLAN INTERNATIONAL PILIPINAS FOUNDATION INC., with office address at 4th Floor Bloomingdale Bldg., 205 Salcedo Street, Legazpi Village, Makati City, a duly registered organization with the Securities and Exchange Commission (SEC) is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, the Association's purposes are as follows:

1. To ensure children and girls realize their rights to education, protection, health care, and high quality of life;
2. To strive for a just world, working together with children, young people, supporters, and partners to advance children's rights and equality for girls;

5. To work with children and communities to prepare for and respond to crises and to overcome adversity; and

WHEREAS, said Association, submitted to this Sanggunian the accomplished requirements and supporting documents for purposes of accreditation and found that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation in favor of Plan International Pilipinas Foundation Inc., as a Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and forthwith issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished to the Department of the Interior and Local Government (DILG) and the NGO concerned.


