RESOLUTION GRANTING THE HONORABLE CITY MAYOR FRANCISCO "ISKO MORENO" DOMAGOSO, REPRESENTING THE CITY GOVERNMENT OF MANILA, AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE – BUREAU OF PLANT INDUSTRY AND THE DEPARTMENT OF AGRICULTURE – NATIONAL URBAN AND PERI-URBAN AGRICULTURE PROGRAM FOR THE PROVISION AND INSTALLATION OF INDOOR CULTIVATION RACKS AT THE CITY MATERIALS RECOVERY FACILITY

WHEREAS, in a letter dated October 27, 2025, Mr. Kenneth G. Amurao, Officer-In-Charge, Department of Public Services (DPS) requested for adoption of a resolution authorizing the Honorable City Mayor Francisco "Isko Moreno" Domagoso to enter into a Memorandum of Agreement (MOA) relative to the provision and installation of Indoor Cultivation Racks at the City Materials Recovery Facility (CMRF). A draft MOA is attached to the letter-request for consideration of this Sanggunian;


WHEREAS, the letter-request, together with the proposed MOA, was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", empowers the local chief executive to enter into contract on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor Francisco "Isko Moreno" Domagoso, representing the City Government of Manila, authority to enter into a Memorandum of Agreement with the Department of Agriculture – Bureau of Plant Industry and the Department of Agriculture – National Urban and Peri-Urban Agriculture Program for the provision and installation of Indoor Cultivation Racks at the City Materials Recovery Facility; and be it FURTHER

RESOLVED, that the duly executed Memorandum of Agreement (MOA) entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
