RESOLUTION GRANTING THE RENEWAL OF ACCREDITATION IN FAVOR OF BUENOS AIRES-G. TUAZON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BAGTTODA) INC., TO BECOME AN ACCREDITED PEOPLE'S ORGANIZATION OF THE CITY OF MANILA

WHEREAS, the BUENOS AIRES-G. TUAZON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BAGTTODA) INC., with office address at 3531 R. Magsaysay Street, Sta. Mesa, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered People's Organization (PO);

WHEREAS, the Association's purposes are as follows:

1. To establish an organization that will represent the tricycle operators and drivers plying the route of Buenos Aires – G. Tuazon and vice-versa;

5. To do and perform all other acts and deeds as maybe necessary, convenient and appropriate for the accomplishment of the foregoing purposes.

WHEREAS, said Association, submitted to this Sanggunian the accomplished requirements and supporting documents for purposes of accreditation and found that it has all the qualifications to be accredited as a People's Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the renewal of accreditation in favor of Buenos Aires-G. Tuazon Tricycle Operators and Drivers Association (BAGTTODA) Inc., to become an accredited People's Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and forthwith issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished to the Department of the Interior and Local Government (DILG) and the PO concerned.
