ORDINANCE NO. 9146

AN ORDINANCE AUTHORIZING THE CITY MAYOR HONORABLE FRANCISCO "ISKO MORENO" DOMAGOSO, TO NEGOTIATE WITH THE OWNER OR INITIATE EXPROPRIATION PROCEEDINGS FOR THE ACQUISITION OF PARCELS OF LAND LOCATED AT 1451 PRESIDENT QUIRINO AVENUE, PACO, MANILA, CONSISTING OF APPROXIMATELY FOUR THOUSAND SQUARE METERS (4,000 SQ. M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 002-2018001374 AND 002-2018991375 TO BE EXCLUSIVELY USED FOR THE ESTABLISHMENT OF DAMAS DE FILIPINAS CHILDREN'S HOSPITAL

EXPLANATORY NOTE

In 1913, the wives of members of the Philippine Columbian Club founded the Asociacion de Damas de Filipinas.

Since its establishment, the Asociacion de Damas de Filipinas dedicated themselves to the service of children who are either abandoned, neglected, or orphaned through the operation of settlement houses, in particular, the one located at 1451 President Quirino Avenue, Paco, Manila.

On 03 December 1998, a fire ravaged the settlement house, causing the loss of twenty-eight (28) lives.

After the fire, while the Asociacion de Damas de Filipinas persisted in their mission, the significant loss of lives and damage to their property greatly hampered their capabilities.

In order to preserve the history of the settlement house, which has become a significant part of the history of the City of Manila and to better serve the Children of the City of Manila, it is imperative for the city to purchase to location of the former settlement house operated by the Asociacion de Damas de Filipinas, and to establish in its place, the Damas de Filipinas Children's Hospital.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION. 1. The City Mayor Honorable Francisco "Isko Moreno" Domagoso is hereby authorized to negotiate or initiate expropriation proceedings for the acquisition of a parcel of land located at 1451 President Quirino Avenue, Paco, Manila covered by Transfer Certificate of Title Nos. 002-2018001374 and 002-2018991375.

SEC. 2. The authorization for expropriation proceedings given herein shall be exercised only in case of failure to acquire the said lots through negotiation with the owner thereof.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was enacted by the City Council of Manila on November 6, 2025.


