WHEREAS, Section 3 of Republic Act No. 5416 otherwise known as the "Social Welfare Act of 1968", mandates the Department of Social Welfare and Development (DSWD) to provide a comprehensive program of social welfare services designed to improve the living conditions of distressed Filipinos particularly those are handicapped by reason of poverty;

WHEREAS, pursuant to the above-stated statute, the DSWD has designed the Sustainable Livelihood Program (SLP) which focuses on the promotion of viable people organization that effectively addresses the livelihood needs of the disadvantaged groups;

WHEREAS, primarily run by the DSWD, SLP aims to improve the socio-economic status of the poor, vulnerable, and marginalized by providing capacity building and opportunities for sustainable livelihood;


WHEREAS, the said DSWD program has two-track system: the Microenterprise Development Track for starting businesses and Employment Facilitation Track for finding jobs, to enhance assets like skills, finances, and social networks to help participants become economically stable;

WHEREAS, the partnership between the DSWD and Barangays aims to develop and implement social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in every Barangay of the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to encourage, as it hereby encourages all Sangguniang Barangays of the six districts of Manila to adopt and implement the Sustainable Livelihood Program (SLP) of the Department of Social Welfare and Development (DSWD) to improve the socio-economic status of the poor, vulnerable, and marginalized members of their respective communities; and be it FURTHER


RESOLVED, that copies of this Resolution be furnished to all concerned Sangguniang Barangays of the six districts of Manila.
