ORDINANCE NO. 9169

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE FRANCISCO "ISKO MORENO" DOMAGOSO, TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF NINE HUNDRED TWENTY-SEVEN SQUARE METERS AND SIXTY SQUARE DECIMETERS (927.60 SQ. M.), MORE OR LESS, LOCATED IN BARANGAY 724, ZONE 79, SINGALONG STREET, MALATE, MANILA, PROVIDING FOR ITS USE AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, **THAT:**

SECTION 1. The acquisition either by negotiation, expropriation or by other legal means, of that certain parcel of land situated at Singalong Street, Malate, Manila, Barangay 724, Zone 79 and owned by the Bank of the Philippine Islands (BPI), covered by Transfer Certificate of Title No. 276043, with a total area of Nine Hundred Twenty-Seven Square Meters and Sixty Square Decimeters (927.60 Sq. M.) is hereby authorized

SEC. 2. The City Mayor is hereby authorized to utilize any available funds in the City Treasury or from the other funding facilities from other government agencies for this purpose.

SEC. 3. The aforementioned parcel of land, when acquired, shall be utilized for purposes of Land-for-the-Landless Program.

SEC. 4. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.
