RESOLUTION GRANTING THE HONORABLE CITY MAYOR, FRANCISCO "ISKO MORENO" DOMAGOSO, REPRESENTING THE CITY GOVERNMENT OF MANILA, AUTHORITY TO ENTER INTO AND SIGN THE DEED OF DONATION WITH THE MÉDECINS SANS FRONTIÈRES PHILIPPINES BRANCH, FOR THE DONATION OF ONE (1) UNIT OF MOBILE CLINIC, WORTH APPROXIMATELY THREE MILLION FIVE HUNDRED FORTY-SIX THOUSAND PESOS (PHP3,546,000.00)

WHEREAS, in a letter dated May 13, 2026, the Secretary to the Mayor, Manuel M. Zarcal, requested for the adoption of a resolution authorizing the Chief Executive of the city to enter into and sign the Deed of Donation with the Médecins Sans Frontières Philippines Branch, relative to the donation of one (1) unit of mobile clinic, worth approximately Three Million Five Hundred Forty-Six Thousand Pesos (PhP3,546,000.00);

WHEREAS, Section 22(c) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", empowers the Local Chief Executive to enter into contracts on behalf of the local government unit upon prior authorization by the Sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Francisco "Isko Moreno" Domagoso, representing the City Government of Manila, authority to enter into and sign the Deed of Donation with the Médecins Sans Frontières Philippines Branch, for the donation of one (1) unit of mobile clinic, worth approximately Three Million Five Hundred Forty-Six Thousand Pesos (PhP3,546,000.00); and be it FURTHER

RESOLVED, that the duly executed Deed of Donation entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
