RESOLUTION GRANTING THE HONORABLE CITY MAYOR FRANCISCO “ISKO MORENO” DOMAGOSO, REPRESENTING THE CITY GOVERNMENT FOR THE MANILA HEALTH DEPARTMENT (MHD), THE AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH – MMCHD), RELATIVE TO THE PROGRAM ENTITLED: “INSECTICIDE RESISTANCE MONITORING IN *Aedes* FOR SUSTAINABLE VECTOR CONTROL (IRMAE)”

WHEREAS, in a letter dated May 11, 2026, the Secretary to the Mayor, Manuel M. Zarcal, requested for the adoption of a resolution granting the Local Chief Executive the authority to enter into a Memorandum of Agreement (MOA) between the City Government of Manila and the Department of Health – Metro Manila Center for Health Development (DOH – MMCHD) for the Manila Health Department (MHD);

WHEREAS, the letter-request, together with the proposed MOA, was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act No. 7160 otherwise known as the “Local Government Code of 1991”, empowers the local chief executive to enter into contract on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor Francisco “Isko Moreno” Domagoso, representing the City Government for the Manila Health Department (MHD), the authority to enter into a Memorandum of Agreement with the Department of Health – Metro Manila Center for Health Development (DOH – MMCHD), relative to the program entitled: “Insecticide Resistance Monitoring in *Aedes* for Sustainable Vector Control (IRMAE)”; and be it FURTHER

RESOLVED, that the duly executed MOA entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
