AN ORDINANCE ABOLISHING ONE (1) SECURITY OFFICER II POSITION AND IN LIEU THEREOF, CREATING ONE (1) LIBRARIAN II POSITION IN THE MANILA CITY LIBRARY, PROVIDING FUNDS NECESSARY THEREFOR AND FOR OTHER PURPOSES

EXPLANATORY NOTE

It is declared national policy under Republic Act No. 7743 to promote the moral and intellectual well-being of the people, elevate the literacy level of every Filipino to the end that illiteracy is eradicated by the end of the century and recognize the vital role of knowledge and information in nation-building by establishing public libraries in every congressional district, city and municipality and reading centers in barangay throughout the Philippines.

The ordinance is an administrative and structural modification measure intended to strengthen the city's frontline and technical library systems consistent with Section 76 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", which empowers local government units to design and modify their respective organization structures and staffing patterns to ensure career development and institutional responsiveness, in order not to defeat the very purpose of R.A. No. 7743, thereby expanding community literacy, public information networks and digital knowledge access.

Section 2.5 of Civil Service Commission (CSC) Memorandum Circular No. 19, Series of 992, provides that: *"In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition shall be made in accordance with pertinent provisions of this Code and the civil service law, rules and regulations"*.

Be it ordained by the City Council of Manila, in special session assembled, *THAT*;

SECTION 1. Abolition of One (1) Security Officer II Plantilla Position. – The position is hereby abolished under the Security Unit of the Administrative Services Division with Salary Grade 15 amounting to a monthly salary of Thirty-Eight Thousand Four Hundred Thirteen Pesos (PhP38,413.00) (Four Hundred Sixty Thousand Nine Fifty-Six Pesos (PhP460,956.00) annually).

SEC. 2. New Plantilla Positions. – The new position of One (1) Librarian II position with Salary Grade of 15 is hereby created under Manila City Library.

SEC. 3. Qualifications, Powers and Duties/Responsibilities. – The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.

SEC. 4. Appointment. – The employment and appointment of the individual for herein subject position shall be within the qualification standard and guidelines set by the Civil Service Commission (CSC) and other relevant agencies.

SEC. 5. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 6. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 08, 2026.

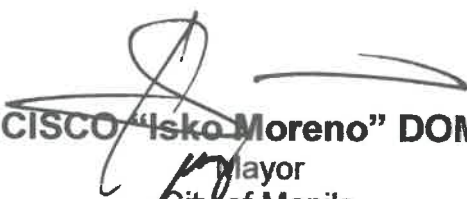

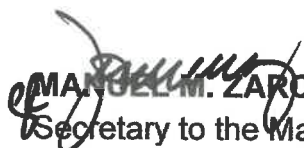
