AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN ADDITIONAL LOADING AND UNLOADING AREAS OF PANDACAN TRICYCLE OPERATORS & DRIVERS ASSOCIATION, INC. (PATODA), AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY EXPANDING ITS ROUTE AREAS AND INCREASING ITS ROUTE MEASURE CAPACITY

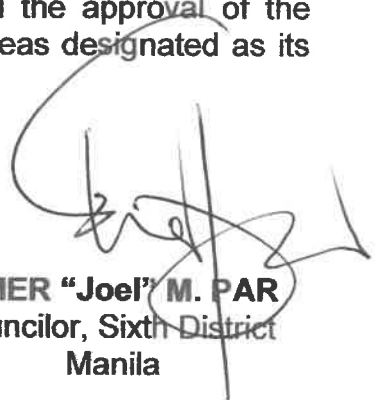


EXPLANATORY NOTE

The Pandacan Tricycle Operators & Drivers Association, Inc. (PATODA) is one of the original transport groups accredited for tricycle franchise and route measure capacity under City Ordinance No. 7871 and granted duly designated terminals by virtue of City Ordinance No. 7755.

PATODA was first registered with the Securities and Exchange Commission (SEC) on 9 March 1987 under SEC Reg. No. 138826 and whose registration was duly renewed after the expiration of its term of existence in 2012.

The said transport association has likewise duly secured the approval of the respective barangays in Pandacan having jurisdiction over the areas designated as its loading and unloading zones.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the Loading and Unloading areas of the Pandacan Tricycle Operators & Drivers Association, Inc. (PATODA), Inc. to read as follows:

**“PANDACAN TRICYCLE OPERATORS & DRIVERS ASSOCIATION,
INC. (PATODA)**

Loading and Unloading Areas

- a. Delas Alas Street corner Dr. M. Carreon Street
- b. Balagtas Street corner Laura Street
- c. Jesus Street and Pandacan Street (Estero de Pandacan) beside Residencia de Manila
- d. Menandro Street corner Laura Street.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route lines of Pandacan Tricycle Operators & Drivers Association, Inc. (PATODA), to read as follows:

“ASSOCIATION

Pandacan Tricycle Operators &
Drivers Association, Inc. (PATODA)

243 Units

ROUTE

M. Carreon-Laura-Beata-Pandacan Bayan-Zamora-Labores Extension.”

SEC. 3. Separability Clause. – If, for any reason or reasons, any part or provision of this Ordinance shall be held invalid, the parts or provisions hereof, shall continue to be in full force and effect.

SEC. 4. Repealing Clause. – All ordinances, rules and regulations that are inconsistent with this Ordinance are hereby repealed or amended accordingly.

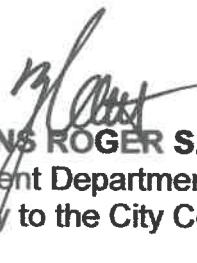
SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.
